Rules and Regulations - Saturday, April 16, 2016

1. Show time is 9:00 a.m. to 2:00 p.m. No Refunds after April 9, 2016.
2. Inside Show Set Up is Friday, April 15, 2016 from 6:00 p.m. to 8:00 p.m. and/or Saturday, April 16, 2016 from 8:00 a.m. to 9:00 a.m. Doors will be open to the Public at 9:00 a.m. Space Assignments will be given when you arrive for set up.
3. Outside Show Set Up is Saturday, April 16, 2016 starting at 7:30 a.m. Space Assignments will be given when you arrive for set up. Vehicles are allowed to be at your site from 7:30 a.m. to 9:00 a.m. All vehicles will need to be moved to the designated parking area no later than 9:00 a.m. No vehicles will be allowed back into the Sale area until after 2:00 p.m.
4. Table(s) and Chair(s) will be provided for Inside Participants only. Electric use will be an extra \$5.00 and will need to be requested upon submitting your application.
5. Outside Vendors will have an 8' X 10' space assigned to them. No tables, chairs, tents, canopies or electric will be provided to Outside Participants. Tents and canopies are allowed, but stakes MAY NOT be driven into the asphalt. Weighted anchors are highly recommended.
6. The sale of real weapons, drug paraphernalia or alcohol abuse related items are prohibited.
7. Payment and signed application is due no later than April 1, 2016 to reserve your space.
8. If you have been a participant with us in the past and would like to request a certain space, please make your request below. No guarantees, but we will try to accommodate your request.
9. This Sale is held in the State of Delaware and does not have Sales Tax. Please refrain from charging Sales Tax regardless of what State you reside in or are sell from.
